#### PROTECTING AGAINST VIATICAL FRAUD

A few weeks ago, some brochures were left in a lobby of a hospital in the metro Boston area. The brochure stated that it was, "For Those Living with Cancer or Other Life-Limiting Illnesses," and invited persons diagnosed with a "life-limiting illness" who have a life insurance policy of at least \$25,000 to call for a "no-cost, no-obligation

policy evaluation to determine the REAL VALUE of your policy."

What the brochure represents is a niche market within the insurance industry known as Viatical Settlements. A Viatical Settlement is an agreement in

which a terminally-ill person sells his or her policy to a viatical company for a cash settlement, and brokers sell the policy to investors. The original intent for these settlements was to assist in paying for additional medical expenses and final wishes. These policies are typically sold if the owner of the policy has less then 24 months of life expectancy. This is a legitimate business transaction but the Federal Trade Commission (FTC) urges policy holders to do their due diligence before entering into a settlement. READ MORE ON PAGE 8

# FREE HELP AVAILABLE FOR INFORMATION ASSURANCE CHALLENGES

If your company is struggling to conquer an Information Assurance (IA) challenge or would appreciate an independent, confidential security review of its operations, Northeastern University can help.

Prof. Michael Higgins, CISM, CPP, the former Chief Security Officer for The New York Times Company and a professor in Northeastern's multi-disciplinary Capstone Course for the Masters of Science in Information Assurance (MSIA) Program, is seeking opportunities for 2-4 member student teams to work with businesses, organizations and governmental entities on solving IA challenges and providing business deliverables according to the problem statement. No problem is too small for consideration, and every participating company will receive free, professional assistance with its concern.

The MSIA Program brings together students from Northeastern's Colleges of Criminal Justice, Business, and Engineering to research and learn all facets of IA challenges. In the Capstone course, the students' undergraduate and graduate curricula are married with their work experiences and applied to a semester-long IA project focused on a real-world problem. Capstone students attend weekly seminars on the business perspective of IA, and the group projects help the students' solidify their understanding of IA's theoretical and practical applications.

Previous Capstone projects have evaluated technologies, performed robust business process reviews, and created new and innovative means to communicate. They have included the creation and documenting of an incident response procedure for a Fortune 1000 company; performing a security vulnerability and risk assessment for a small 20-person start-up company to support their A round of financing; developing a consumer-focused awareness campaign for a small metropolitan police department; developing a physical security policy and execution plan for a mid-size multi-national engineering corporation; and creating a process and conducting the evaluation to replace a legacy PBX system where security was one of the primary decision considerations for a purchase. In all cases, IA or Information Security was a primary concern.

Higgins anticipates having approximately 10 teams of students available starting January 1, 2012. Participating companies will work with a highly motivated, part-time work force that has a solid understanding of IA and seeks to provide true value in their projects.

With tongue firmly wedged in cheek, Higgins describes himself as, "a mid-dle-aged 20+ year veteran security professional who is mildly knowledgeable in matters of security, privacy and risk." As a project mentor, he will provide weekly oversight to keep the projects on track and focused on addressing the problem statement.





## VIATICAL FRAUD CONTINUED FROM PAGE 1

Like many legitimate business transactions, there are always opportunities for fraud. Viatical insurance fraud takes place when applicants make a material misrepresentation by answering "no" to all of the questions regarding their health status (any life-threatening disease) and no physical is given. This becomes insurance fraud when the applicant is actually terminally ill.

Typically, the fraudulent scheme begins when applicants are recruited by either an agent or a broker through a resource center or support group for terminally ill people. The applicants are then asked to pay a fee for submitting the application to the insurance company. A typical fee payment is usually between 1% and 2% of the value for the policy. Once the policy is issued, it is retained by the viatical company.

This practice often becomes a type of pyramid scheme by using applicants as recruiters who receive a fee for submitting leads to the brokers. Once a policy is issued, ownership is then transferred into a trust in the name of the policy holder. The owner then appoints a representative of the company as the trustee of the policy, who then sells the policy to an investor. The investors are unaware that their policies are fraudulent. The investors are advised that if a policy is cancelled, it will be replaced by another policy with no additional fees or charge. This scheme may be causing the insurance industry to incur substantial losses on an annual basis.
